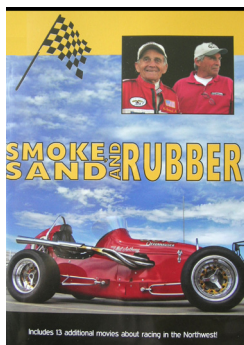
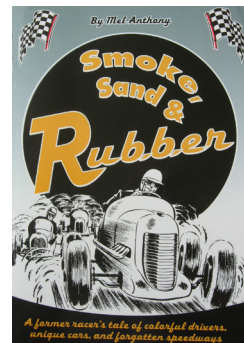

## "Smoke, Sand and Rubber" the book

Mel Anthony shares his first-hand Northwest auto racing history knowledge from the 1930's through the 1950's, including his own experiences and life story. A glimpse into the daring West Coast midget racers who led an early era in auto racing. Mel tells of accomplished drivers who would go on to Indy, plus tracks, cars that have been restored - some even appearing in vintage events today -and how it was like to start his first race in 1946 and how he competed with some of the best drivers to run in the Pacific Northwest and beyond. The well-told stories are injected with Mel's humor, and many historic photos.



## "Smoke, Sand and Rubber" the documentary DVD

Produced by young filmmaker Greg Brotherton, the documentary features Mel Anthony, a race car driver in his eighties still going strong racing a restored 1947 Kurtis Offy, co-owned by his son Dennis. With Dennis turning wrenches, Mel gets behind the wheel of a midget for the first time in fifty+ years and takes the #12 car out on the oval tracks around the Pacific Northwest.

Filled with his races today, vintage racing footage from the 1940's and 1950's, and Mel's natural storytelling, Smoke, Sand and Rubber is filled with humor, great storytelling and interviews. Also featured are 13 additional movies about racing in the Northwest, including Golden Wheels, the vintage racing club who continue to preserve, restore and race, and many of it's members.
